## GRANTING SPECIAL USE ZONING PERMIT IPS SALES CORPORATION SIGN - SOUTHWEST CORNER of US ROUTE 34 & ELDAMAIN ROAD

TOTAL SOLUTION OF THE PROPERTY OF THE PROPERTY AND ADDRESS OF THE PROPERTY OF

<u>WHEREAS</u>, IPS Sales Corporation filed a petition for special use approval of a sign at the southwest corner of the intersection of US Route 34 and Eldamain Road; and

<u>WHEREAS</u>, said property is currently zoned A-1 Agricultural District and is further identified on the attached Exhibit A: Legal Description; and

<u>WHEREAS</u>, said petition is for a sign advertising property other than the site in which the sign is located and conforming to all other regulations; and

<u>WHEREAS</u>, all procedures required by the Kendall County Zoning Ordinance were followed including notice for public hearing, preparation of the findings of fact, and recommendation for approval by the Zoning Board of Appeals.

<u>WHEREAS</u>, the Kendall County Board finds that said petition, along with the conditions specified in this ordinance, is in conformance with the provisions of the Kendall County Zoning Ordinance;

<u>NOW, THEREFORE, BE IT ORDAINED</u>, that the Kendall County Board hereby grants approval of a special use zoning permit to construct a sign on the property at the southwest corner of Eldamain Road and US Route 34 at the site specified on Exhibit A for a period of three (3) years from the date of approval and renewable for additional one (1) year increments.

Failure to comply with the terms of this ordinance may be cited as a basis for amending or revoking this special use permit.
