WHEREAS, the Governor of the State of Illinois on March 9, 2020 issued a Declaration of Disaster in response to the COVID-19 Pandemic; and the President of the United States of America on March 13, 2020 declared a National Emergency concerning the COVID-19 Pandemic; and

WHEREAS, on March 20, 2020, the Governor of the State of Illinois issued Executive Order 2020-10 directing, among other issues, that residents of the State of Illinois stay at home and observe appropriate social distancing; and

WHEREAS, in furtherance of the response to the COVID-19 Pandemic, the Governor of the State of Illinois on April 1, 2020, in Executive Order 2020-18, extended the Declaration of Disaster for an additional 30 days through April 30, 2020; and

WHEREAS, Executive Order 2020-18 also extended the duration of Executive Order 2020-10 through April 30, 2020; and

WHEREAS, the Centers for Disease Control, the Illinois Department of Public Health, and the Health Department of Kendall County has declared and recognized the existence of a public health emergency due to the spread of respiratory illness resulting from exposure to a novel coronavirus identified as COVID-19; and

WHEREAS, persons found guilty of driving under the influence in the Circuit Court of Kendall County are required to attend a Victim Impact Panel; and

WHEREAS, pursuant to Administrative Order 19-10, the next regularly scheduled Victim Impact Panel is scheduled to be conducted on May 28, 2020; and

WHEREAS, in the event that social distancing is no longer mandated by the Governor of the State of Illinois, it may be prudent for individuals to voluntarily observe social distancing, making it difficult to personally attend a Victim Impact Panel; and


WHEREAS, Mothers Against Drunk Driving (MADD) offers an online Victim Impact Panel which permits those individuals ordered to attend a Victim Impact Panel to successfully comply with the court order and maintain appropriate social distancing;

NOW THEREFORE, IT IS ORDERED:

Those individuals previously ordered to attend the May 28, 2020 Victim Impact Panel in Kendall County may attend the Online Victim Impact Panel offered by MADD in satisfaction of their obligation as previously ordered. Any individual attending the online Victim Impact Panel is responsible for providing proof of attendance to the Clerk of the Circuit in fulfillment of his or her obligation as previously ordered.
