ORDINANCE #95 16

GRANTING SPECIAL USE ZONING PERMIT WADE PRESCHOOL 3475 ELDAMAIN ROAD Plano. Illinois

WHEREAS, the Kendall County Zoning Ordinance was amended on August 15, 1995 by Ordinance 95-11 adding "Day Care, preschool, and nursery schools, public and private" as an allowable special use in the A-1 Zoning District; and

WHEREAS, the owner of the property at 3475 Eldamain Road, section 24, Little Rock Township, Kendall County Illinois filed an application and all necessary documentation with Kendall County requesting a special use permit for a preschool; and

WHEREAS, said property consists of two adjacent parcels totaling 2.5 acres which is shown on the attached Plat of Survey Exhibits A and B, it is zoned as A-1 Agricultural District, it contains a single family residence occupied by the owner and a vacant building to be used for the preschool; and

WHEREAS, all administrative procedures required by the Kendall County Zoning Ordinance were followed including review by Little Rock Township, City of Plano, Regional Planning Commission, notice for public hearing by the Zoning Board of Appeals, findings of fact and recommendations by the Zoning of Appeals;

WHEREAS, the Kendall County Board finds that said request complies with all provisions of the Kendall County Zoning Ordinance including the A-1 standards and the special use standards.

NOW THEREFORE, BE IT ORDAINED, that the Kendall County Board hereby grants approval of a special use permit to construct and operate a preschool and maintain an existing single family residence on the property at 3475 Eldamain Road in substantial

conformance to the attached Site Plan Exhibit C and according to the conditions as follows:

- 1. The preschool facilities and operation shall be built, maintained, and operated in conformance with all State and Federal regulations including the Department of Children and Family Services permits and inspections.
- Student enrollment shall not exceed 20 at one time.
- 3. The owners shall file evidence with Kendall County and other requesting jurisdictions of liability insurance not less than \$5000.
- 4. The preschool facilities and operations shall be built, maintained, and operated in conformance with all local regulations including Kendall County zoning and health ordinances.
- 5. The owner shall allow periodic Kendall County Zoning and Health Department inspections of the property.
- 6. The owner shall dedicate sufficient land for an expansion of Eldamain Road right of way upon request of the appropriate jurisdiction.




