

ORDINANCE

AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED

WHEREAS, Robert Higley did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and the ordinances of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted January 16, 1940; and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed amendment on the 12th day of May, 1980, A.D. on the site described in the petition.

NOW THEREFORE, BE IT ORDAINED by the County Board of Kendall County, Illinois that the following described property be and it is hereby rezoned from A1, Agriculture District to R2 and R3, Single Family District and that the County Clerk be and she is hereby ordered and directed to change the zoning map, to show the change in zoning classification:

TO BE ZONED R-2: That part of the North half of Section 6, Township 36 North, Range 8 East and part of the Northeast Quarter of Section 1, Township 36 North, Range 7 East of the Third Principal Meridian and part of Waish-Kee-Shaw Reservation described as follows: Commencing at the Northwest corner of said Section 6: thence South $1^{\circ}07'27''$ East along the West line of said Section 6, 872.0 feet; thence North $86^{\circ}00'37''$ East, 798.90 feet for a point of beginning; thence South $86^{\circ}00'37''$ West, 60.17 feet; thence South $0^{\circ}16'07''$ West, 540.0 feet; thence North $89^{\circ}43'53''$ West, 290.0 feet; thence South $35^{\circ}41'13''$ West, 350.0 feet; thence North $53^{\circ}17'03''$ West, 330.0 feet; thence South $14^{\circ}44'50''$ West, 123.26 feet to a stone monument; thence South $3^{\circ}18'47''$ West, 700.43 feet; thence South $87^{\circ}08'31''$ West, 604.75 feet; thence South $0^{\circ}16'07''$ West, 495.0 feet; thence North $87^{\circ}08'31''$ East, 891.05 feet to a Westerly line of said Reservation; thence North $0^{\circ}16'07''$ West along said Westerly line, 599.56 feet to a point which is 259.38 feet North of the North line of the south half of said Reservation; thence South $89^{\circ}42'00''$ East, 599.96 feet; thence North $0^{\circ}16'07''$ East, 1,162.99 feet; thence North $86^{\circ}00'37''$ East 60.17 feet to the point of beginning in the Township of Kendall and Na-Au-Say, Kendall County, Illinois.

TO BE ZONED R-3: That part of the South half of Section 31, Township 37 North, Range 8 East and part of the North half of Section 6, Township 36 North, Range 8 East and part of Waish-Kee-Shaw Reservation described as follows: Commencing at the Northwest corner of said Section 6: thence South $1^{\circ}07'27''$ East along the West line of said Section 6, 872.0 feet; thence North $86^{\circ}00'37''$ East, 798.00 feet for a point of beginning; thence South $86^{\circ}00'37''$ West, 60.17 feet; thence North $89^{\circ}30'01''$ East 360.36 feet; thence North $0^{\circ}16'07''$ East, 1,813.34 feet to the center line of Reservation Road; thence South $89^{\circ}30'01''$ West along said center line, 360.36 feet to a line drawn Northerly parallel with the West line of said Reservation from the point of beginning; thence South $0^{\circ}16'07''$ West, 1,643.76 feet to the point of beginning in Oswego

Township and Na-Au-Say Township, Kendall County, Illinois.
