ORDINANCE
AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED 26

WHEREAS, Harold Hall did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and the ordinance of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted May 10, 1960; and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed amendment on the 20th day of October, 1981 on the site described in the petition and at the conclusion of said hearing said Zoning Board of Appeals voted in favor of recommending to the County Board of Kendall County, Illinois that the petition be granted and the Zoning maps and ordinance be amended in the manner required by law; and


NOW THEREFORE, BE IT ORDAINED by the County Board of Kendall County, Illinois that the following described property be and it is hereby rezoned from A1, Agricultural District to R3, Residential District and that the County Clerk be and she is hereby ordered and directed to change the zoning map, to show the change in zoning classification:

That part of the Northeast Quarter of Section 26, Township 37 North, Range 8 East of the Third Principal Meridian, described as follows: Commencing at the Southwest corner of the Northeast Quarter of said Section 26; thence South 89°31'37" East along the South line of the Northeast Quarter of said Section 26, 680.26 feet; thence North 0°44'37" West 682.5 feet for a point of beginning; thence North 89°16'23" West 335 feet; thence South 0°04'37" south 135 feet; thence South 89°16'23" East 325 feet; thence North 0°44'37" north 135 feet to the point of beginning; all in the Township of Oswego, Kendall County, Illinois, containing 1 acre or more.

ORDINANCE

That part of the Northeast Quarter of Section 26, Township 37 North, Range 8 East of the Third Principal Meridian, described as follows:
Commencing at the Southwest corner of the Northeast Quarter of said Section 26; thence South 89°31'37" East along the South line of the Northeast Quarter of said Section 26, 680.26 feet; thence North 0° 44' 37" West 682.5 feet for a point of beginning; thence N 89°15'23" East 335 feet; thence S 0°44'37" East 135 feet; thence S 89° 15' 23" West 335 feet; thence North 0° 44' 37" West 135 feet to the point of beginning; all in the Township of Oswego, Kendall County, Illinois containing 1 acre or more.
