AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED

WHEREAS, Rudolf & Judy Bahr did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and ordinances of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted January 16, 1940; and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed map amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed map amendment on the 18th day of November, 1988 in the Kendall County Board Room and at the conclusion of said hearing said Zoning Board of Appeals voted in favor of recommending to the County board of Kendall County, Illinois that the petition be granted and the Zoning maps be amended; and

NOW THEREFORE, BE IT ORDAINED by the County Board of Kendall County, Illinois that the following described property be and it is hereby reclassified from A1, Agriculture District to R3, Single Family District and that the Zoning Administrator be hereby ordered and directed to change the zoning map to show the change in zoning classification, legally described as follows:

Parcel One: That part of the Southeast Quarter of Section 31, township 37 North, Range 8 East of the Third Principal meridian, described as follows: Beginning at the Southwest corner of Mo-Ah-Way Reservation and on the North line of Waish-Kee-Shaw Reservation, being the center line of Reservation Road; thence North 89°56'47" East along the centerline of said Reservation Road, 261.78 feet; thence South 00°04'02" West, 249.74 feet; thence North 89°55'58"

West, 261.78 feet to a point South 00`04'02" West of the point of beginning; thence North 00`04'02" East, 294.47 feet to the point of beginning, in the Township of Oswego, Kendall County, Illinois.

Parcel Two: That part of the Southeast Quarter of Section 31, township 37 North, Range 8 East of the Third Principal Meridian, described as follows: Commencing at the Southwest corner of Mo-Ah-Way Reservation and on the North line of Waish-Kee-Shaw Reservation, being the center line of Reservation Road; thence North 89 56'47" East along the center line of said Reservation Road; 261.78 feet; thence South 00`04'02" West 249.74 feet; thence North 89`55'58" West, 261.78 feet; thence North 00`04'02" East, 249.74 feet; thence North 89`56'47" East, 261.78 feet, to the point of beginning, in the Township of Oswego, Kendall County, Illinois.
