Meeting Minutes

CALL TO ORDER

The meeting was called to order by Chair Judy Gilmour at 3:09p.m.

ROLL CALL

Committee Members Present: Tony Giles - here, Matthew Prochaska – here, Judy Gilmour – here

Member John Purcell entered the meeting at 3:16p.m. and left the meeting at 3:45p.m.

Members Absent: Elizabeth Flowers

Others Present: Megan Andrews, Dr. Amaal Tokars

APPROVAL OF AGENDA – Member Prochaska made a motion to approve the agenda, second by Member Giles. **With three members present in agreement, the motion carried.**

APPROVAL OF MEETING MINUTES – Member Prochaska made a motion to approve the meeting minutes from January 9, 2017, second by Member Giles. **With three members present voting aye, the motion carried.**

STATUS REPORTS

- **Board of Health** – Member Giles updated the committee on the last meeting in which they reviewed the Strategic Plan. The Board of Health meets tonight, and Member Giles will continue to update the committee each month.
- **Health Department** – Dr. Tokars presented the 2017/2018 Immunization Clinic schedule, and said that they offer Back to School Immunizations, Flu Clinics, Travel Clinics, as well as several other clinics to the community. Dr. Tokars stated that the need for immunizations has increased at local Health Departments, as well as private medical facilities in recent years.

Dr. Tokars also informed the committee of a new program entitled “Cooking Matters” that was developed to assist families in purchasing healthy and affordable foods. The program is hosting a Grocery Store Tour that will teach participants in buying fruits and vegetables on a budget, comparing prices to find bargains, reading and comparing food labels, identifying whole grains and sticking to a budget when shopping.

Dr. Tokars distributed the current Health Department newsletter and highlighted several areas of interest, including the article on the Seoul Disease that is prevalent in rats.

Dr. Tokars also distributed the Health Department Annual Report and stated that when it is posted on the Health Department website that it will include a link to their Strategic Plan as well.

Member Gilmour also informed the committee of a question that was asked at the last County Board meeting by the gentleman that asked the County to adopt the “Cupcake or Home Kitchen law” so that he could make and sell baked goods from his home, regarding his production of barbeque sauce. Dr. Tokars stated that there isn’t a current law that applies to that specific product, but there could be in the future.

- **Kendall County Soil and Water District** – Megan Andrews reviewed the U.S. Drought Monitor report, and informed the committee about the upcoming Farm and Safety Camp planned for June 13, 2017 at the Kellogg Farms in Yorkville. Ms. Andrews said that the camp fills up quickly with participants from 7 – 11 years old.

Ms. Andrews reported their annual Fish Sale pickup will be next week, and that Tree Sale orders are due this Friday, with pickup on April 7th.

Ms. Andrews also informed the committee of the Natural Resources Tour at Hoover on May 4th, May 10th and May 11th, with different stations on natural resources given by personnel from the Health Department, KC Soil & Water Conservation District, and the Forest Preserve. District. There are participants from 4th and 5th grade public school students from Oswego, Plano, Yorkville, as well as 4th and 5th grade students from Cross and Parkview Christian schools.

- **Water Related Groups** – No report

OLD BUSINESS – Member Gilmour stated that the Food Protection, Onsite Water Treatment System and Water Supplies Ordinances all came back with approval from the State of Illinois.

Rain Barrel Month Proclamation – Member Prochaska made a motion to forward the resolution with the changed date of April 5, 2017 to the Board for approval, second by Member Giles. **With three members voting aye, the motion carried.**

AN INTERGOVERNMENTAL AGREEMENT
BETWEEN KENDALL COUNTY, ILLINOIS, AND
WILL COUNTY, ILLINOIS

THIS AGREEMENT is made and entered into by and between KENDALL COUNTY and WILL COUNTY, hereinafter collectively "the parties," and is effective on the last date signed by a party hereto.

WHEREAS, Section 10 of Article VII of the Illinois Constitution of 1970, and the Intergovernmental Cooperation Act, 5 ILCS 220/1, *et seq.*, enable the parties to enter into agreements among themselves and provide authority for intergovernmental cooperation; and

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220/1 *et seq.*, provides that any power or powers, privileges or authority exercised or which may be exercised by a public agency of this State may be exercised and enjoyed with any other public agency of this State; and

WHEREAS, WILL COUNTY and KENDALL COUNTY have authority to conduct electronics recycling operations as specified under the Electronic Products Recycling and Reuse Act, 450 ILCS 150/1 *et seq.*, and other statutes referenced therein; and

WHEREAS, the Electronic Products Recycling and Reuse Act, 450 ILCS 150/1 *et seq.*, prohibits the disposal of certain types of electronic devices in landfills; and

WHEREAS, KENDALL COUNTY has agreed to host one one-day collection events during 2017 for residential electronics recycling, with a limit of two televisions per household; and

WHEREAS, WILL COUNTY and KENDALL COUNTY maintain residential electronics recycling and processing contracts with an independent, certified company; and

WHEREAS, WILL COUNTY has a contract with a Manufacturer Funded Electronics Recycler to recycle up to a certain amount, by weight, of residential electronics items; and

WHEREAS, WILL COUNTY has excess capacity under its Manufacturer Funded Electronics Recycler contract and can accommodate within that capacity the total weight of products estimated to be collected at KENDALL COUNTY's two one-day collection events in 2017; and

WHEREAS, WILL COUNTY seeks to utilize most or all of its capacity under its Manufacturer Funded Electronics Recycler contract, and would benefit from doing so; and

WHEREAS, KENDALL COUNTY would reduce the costs of its residential electronics recycling operations by sending the items collected at its two one-day collection events to WILL COUNTY's Manufacturer Funded Electronics Recycler;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

and all losses, damages, or expenses, including reasonable attorneys' fees, arising out of or resulting from claims or actions for bodily injury, death, sickness, property damage, or other injury or damage if caused by any negligent act or omission of such party, its officials, officers, employees or agents in the execution or performance of this agreement (except to the extent caused by the negligent act or omission of the other party, its employees, or agents). Written notice of any claims shall be given in a timely manner. This indemnification clause shall survive termination of this agreement. Nothing in this section alters the immunities provided all parties to this agreement under the Local Governmental and Governmental Employees Tort Immunity Act, 745 ILCS 10/1-101.

SECTION 6. Term. The term of this Agreement shall begin upon the execution of this Agreement and shall remain in full force and effect until February 1, 2018. This agreement may be terminated by sixty (60) days written notice by either party without cause.

SECTION 7. Entire Agreement. This Agreement contains the entire understanding of the parties with respect to the subject matter hereof and all prior or contemporaneous agreements, understanding, representations and statements, oral or written, are merged herein. This Agreement may be modified only by written instrument executed by the parties.

SECTION 8. Waiver. No consent or waiver, express or implied, as to any provisions of this Agreement shall constitute a consent or waiver of any other provisions, whether similar or dissimilar, of this Agreement.

SECTION 9. Captions. The captions of this Agreement are inserted for convenience of reference only, and do not define, describe, or limit the scope or intent of this Agreement.

SECTION 10. Notices. Notices to the parties shall be in writing and delivered by electronic mail, personal service or by U.S. certified or registered mail, postage prepaid, to the parties at the following addresses:

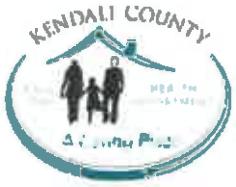

House Keeping Tips for Reducing Exposure to Lead-laden Dust

Practice Good Hygiene

Small children have hand-to-mouth tendencies, so they often place items such as hands and toys in their mouth. If these items are contaminated with lead dust, a child can become lead poisoned by ingesting small amounts of lead. Regularly washing these items is an important step to prevent lead poisoning.

- Wash children's hands, face, and mouth often, especially before every meal and before naptime.
- Wash toys, pacifiers, and bottles, especially after they fall on the floor.
- Wash surfaces frequently and thoroughly where food is prepared.
- Wash clothes contaminated with lead separately from others.
- Keep fingernails short so that lead dust cannot be easily trapped.

Lead Dust Control

Lead dust can come from chipping or peeling lead paint. Also, lead dust can enter your home from outside. You can control how much lead dust is created or enters the home by:

- Frequently cleaning the house and wiping down surfaces.
- Picking up paint chips that you find on the floor, inside windows, or in other places where your children play.
- Having people remove their shoes before coming indoors.
- Placing washable doormats at all entries of your home and wash them weekly.
- If you remodel or renovate certain areas, follow lead-safe procedures.

Cleaning Tips

Cleaning Hard Surfaces and Floors

Lead dust can accumulate on surfaces inside a home, which can expose children to unsafe levels of lead. To clean properly:

- Wipe or dust flat surfaces with a wet rag or paper towel on a frequent basis.
- Wipe down walls, window sills, steps, grates, registers, baseboards, and other hard surfaces weekly.
- Wet sweep floors before mopping by spraying floor with cleaning solution or water, then sweep.
- *Do not dry sweep*

Cleaning Carpeted Floors

- If you know your carpet is contaminated, consider removing the old carpet. Replacing carpeting with nonporous flooring such as tile or wood makes it easier to clean and it traps less lead dust.
- Do not use a regular household vacuum cleaner to clean up lead paint chips or peeling paint. Instead, use a high-efficiency particulate air filter (HEPA) vacuum rated for lead dust so that lead dust does not contaminate the air.
- Some communities or hardware stores may sell or offer a loaner HEPA vacuum for household where children have lead poisoning.

Lead poisoning is the number one environmental disease in children under the age of six. Ingestion of lead dust is the leading cause of elevated blood lead levels.

Hand to mouth activity of young children is the most common way lead enters the child's body.

Currently, the lead threshold is 5 ug/dL (micrograms lead per deciliter of whole blood). Note: A microgram is about the size of a grain of sugar.

All children 6 months through 6 years old should be assessed for their risk of lead poisoning. Illinois state law requires all children entering day care, nursery school, preschool or kindergarten to provide proof of a blood lead test or a lead assessment.

A child may be at risk if:

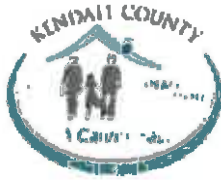
- The child spends time in a building built before 1978
- Renovation has been done to the house just before or during the time the child lived in the house
- House is near heavy industry or traffic where lead has contaminated the ground
- A family member works with lead
- Lead-containing pottery or folk remedies
- A brother or sister has an elevated blood lead level
- The child plays in soil
- The child eats off lead-glazed dishes or chews on a lead-painted crib or toy

Protect your child from Lead

- Wash your children's hands before they eat.
- Provide foods high in iron and calcium (lean meat, eggs, raisins, greens, milk, cheese, fruit and potatoes) which decreases the binding effect of lead in a child's system.
- Clean up chipping and peeling paint inside and outside of home.
- Clean up window sills, lead dust with damp rag/mop.
- Wash your child's toys often. Throw away lead-painted toys.
- Do not store food in open cans or pottery.
- If you work with lead, remove clothes before coming home. Wash work clothes separately.
- Run cold water for a few minutes before using it for cooking and drinking. Do not use water from the hot water tap for cooking, drinking or making formula.

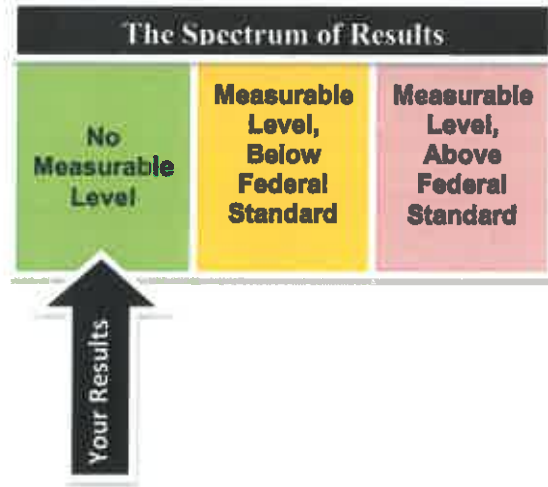

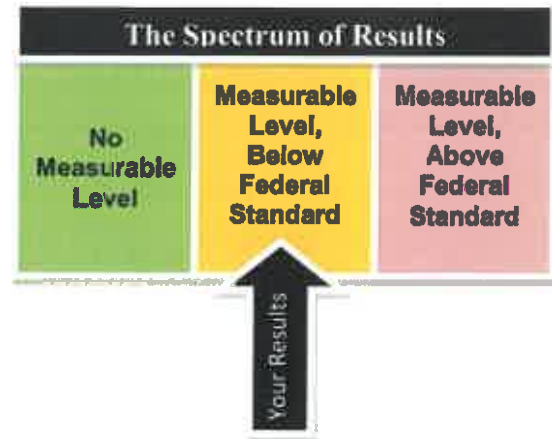

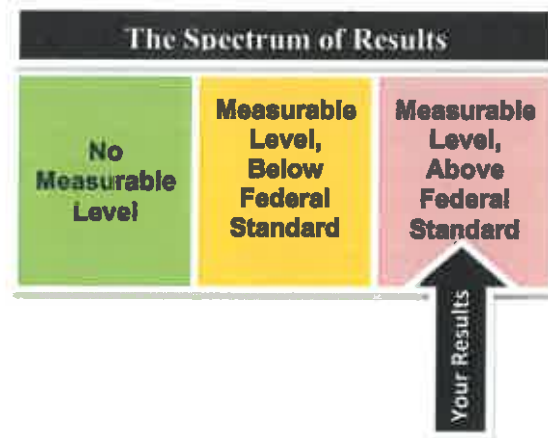
