Status Reports

Coroner – Coroner Purcell reviewed the monthly report with the committee, and reported 35 deaths: Responded to 5 scenes, transported 5 and 2 external examinations. <u>Written report</u> provided.

EMA – <u>Written report provided</u>. Director Joe Gillespie reported search and rescue training continued. Severe weather training with a large group of the community attending was successful. Siren and STARCOM testing is continuing. WSPY will have a tower climber out this week to replace an antenna that was knocked off during microwave upgrades. EMA is working closely with the Kendall County Health Department regarding the changing status of the Corona Virus. Mr. Gillespie and Dr. Tokars meet twice a week to stay abreast of state and federal guidelines. Committee discussed ordinances and laws of electronic meetings if they become necessary.

Public Defender – Written report provided. Public Defender Chuffo provided.

Court Services –Director Elliott provided information on the updated process for law enforcement to process youth offenders direct with Kane County Juvenile Justice Center. Training will be on April 1st and 9, 2020. Ms. Elliott also informed the Committee the IGA with Kane County Juvenile Justice Center will expire in November 2020. Ms. Elliott is in process of comparing River Valley Detention Center in Joliet and Kane County Juvenile Justice Center in St. Charles. <u>Written report provided</u>.

Commander Langston reported the fee study that previously passed through the Law, Justice and Legislation Committee is underway, anticipates to provide information for the April meeting. Working with Dr. Tokars and the Kendall County Health Department for best practices on prevention of the Corona Virus for staff and patrol.

EMA/Search and Rescue Report

MAY 2020

May 9 - Multi Agency Search and Rescue Training was cancelled due to the COVID-19 virus pandemic.

May 15 - Missing person search for 18 YOA autistic female. Search was cancelled as teams arrived due to the danger of the rising flood waters in the dark.

May 16 - Missing person search for 18 YOA autistic female. Search was attended by five (5) Kendall County EMA SAR personnel. A Total of fifty-seven (57) search personnel took part in the search. The missing subject was not found. We were to search again when the flood waters receded.

May 21 - Missing person search for same 18 YOA autistic female. Search was attended by four (4) Kendall County EMA SAR personnel. A total of forty-five (45) search personnel took part in the search. The missing subject was not found. K9 resources were to return the next day to continue to search. The female missing subject was found drowned 5.6 miles from last known point on May 26.

May 29 - Missing per search for 27 YOA suicidal bipolar male. Search developed leads as to a sighting of missing person by Kendall County EMA SAR team. Search was attended by five (5) Kendall County EMA SAR personnel. A total of thirty-one (31) search personnel took part in the search. It is unknown if the subject has yet to be located.

COVID-19

- EMA volunteers loaded and deliver 1,700 isolation gowns, and 2,000 masks to 4 LTCF on May 27th.
- Made additional PPE orders and will be delivered to Oswego Dist 308 and the Regional Office
- Daily SitRep published.
- Attending PPE and IEMA Region 3 meetings 3 times a week.
- Provided information to IEMA on short notice requests.

Weather

- Responded to severe weather, opening the EOC on Saturday, May 23rd (afternoon). Significant rain and many multi-cell storms crossed Northern Illinois. A weak tornado was reported in Sandwich early on, but didn't last long and was in a field.
- Flooding; no major flooding occurred in Kendall County after receiving 1.9" of rain. However, some roads in the southern portion of the County were made impassable for a few days.

EMA has done several press releases with general information for COVID-19. We also have been updating our Facebook page.

Family Violence Coordinating Council grant for the new state fiscal year is ready for approval and signatures. This is the second year for the grant which is between the State of Illinois Criminal Justice Information Authority and the 16th and 23rd Judicial Circuit. Kendall County serves as a fiscal agent only. The expenditures are equal to the revenue. Should the revenue amount decrease as it relates to the passing of the state budget, so too would the expenditures.

On May 23rd the General Assembly adopted the state budget with full funding for the Illinois Supreme Court. Part of that budget is full funding for **probation officer reimbursements** for the counties. This is good news for Kendall County as we converted some of the fully county funded positions last year to reimbursable positions, We should receive our appropriations letter from AOIC sometime in late July or August. It is worth noting that during the appropriation hearings, legislators expressed the need for a robust probation/pretrial division as the focus on reducing the numbers of those incarcerated increases.
