ORDINANCE 78-6

AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED

WHEREAS, Richard B. Wormley did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and the ordinances of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted May 10, 1960; and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed amendment on the 18th day of April, 1978, A.D. on the site described in the petition and at the conclusion of said hearing said Zoning Board of Appeals voted in favor of recommending to the County Board of Kendall County, Illinois that the petition be granted and the Zoning maps and ordinance be amended in the manner required by law; and

<u>NOW THEREFORE, BE IT ORDAINED</u> by the County Board of Kendall County, Illinois that the following described property be and it is hereby rezoned from Al, Agricultural District to ALSU, Agricultural District Special Use, restricted area for single engine light aircraft and that the County Clerk be and she is hereby ordered and directed to change the zoning map, to show the change in zoning classifications:

That part of the East half of the Southeast quarter of Section 13, Township 37 North, Range 8 East of the Third Principal Meridian, described as follows: Commencing at the Southwest corner of said Southeast quarter; thence East along the South line of said quarter section 2330.1 feet for the point of beginning; thence West along said South line 113.6 feet to a point 2216.5 feet East of the Southwest corner of said Southeast quarter; thence North along a line forming an angle of 90°22' measured counterclockwise from the last described course 350 feet; thence West parallel with the South line of said quarter section 150 feet; thence North along a line forming an angle of 90°22' measured counterclockwise from the last described course 85.6 feet; thence West parallel with the South line of said quarter section 81 feet; thence North along a line forming an angle of 90°26' measured counterclockwise from the last described course 2212.67 feet to the North line of said Southeast quarter; thence East along said North line which forms an angle of 89°22' measured counterclockwise from the last described course, 329.5 feet; thence Southerly to the point of beginning, in the Township of Oswego, Kendall County, Illinois

BE IT FURTHER ORDAINED that the above special use classification shall be expressly made subject to the following conditions:

1. The airstrip will not be lighted.

The use will be limited to one single engine aircraft, limited to the use of the owner.
