

ORDINANCE

AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED


WHEREAS, Anthony J. Bassak did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and the ordinances of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted May 10, 1960; and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed amendment on the 3rd day of December, A.D. 1976 on the site described in the petition and at the conclusion of said hearing said Zoning Board of Appeals voted in favor of recommending to the County Board of Kendall County, Illinois that the petition be granted and the Zoning maps and ordinance be amended in the manner required by law; and

NOW THEREFORE BE IT ORDAINED by the County Board of Kendall County, Illinois that the following described property be and it is hereby rezoned from A1, Agricultural District, to R3, Residential District and that the County Clerk be and she is hereby ordered and directed to change the zoning map, to show the change in zoning classification:

That part of the East half of Section 7, Township 36 North, Range 7 East of the Third principal meridian, described by commencing at the Southwest corner of said Section 7; thence North $1^{\circ}45'36''$ east along the west line of said Section, 695.70 feet to the present center line of State Highway Route No. 71; thence north $71^{\circ}11'00''$ east along said center line 37.40 feet; thence northeasterly along said center line being on a curve to the left having a radius of 6611.12 feet and being tangent to the last described course at the last described point, an arc distance of 2901.95 feet; thence north $46^{\circ}02'00''$ east along said center line, being tangent to the last described curve at the last described point, a distance of 724.75 feet to the center line of Legion Road running easterly; thence south $71^{\circ}48'00''$ east along said center line 616.16 feet to an angle in said center line; thence south $74^{\circ}23'00''$ east along said center line 865.05 feet for a point of beginning; thence North $14^{\circ}59'29''$ east 554.98 feet; thence north $50^{\circ}11'28''$ west 312.67 feet; thence south $35^{\circ}16'16''$ west 237.13 feet; thence south $21^{\circ}35'37''$ west 462.28 feet to the center line of Legion Road; thence South $74^{\circ}23'00''$ east along said center line 419.16 feet to the point of beginning and containing 5.392 acres, situated in the Township of Kendall, County of Kendall, State of Illinois.
