AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED

WHEREAS, Edwin L. Lindow, did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and the ordinances of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted May 10, 1960 and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed amendment on the 5th day of January, A.D. 1972 on the site described in the petition and at the conclusion of said hearing said Zoning Board of Appeals voted in favor of recommending to the Board of Supervisors of Kendall County, Illinois that the petition be granted and the Zoning maps and ordinance be amended in the manner required by law.

NOW THEREFORE, BE IT ORDAINED by the Board of Supervisors of Kendall County, Illinois that the following described property be and it is hereby rezoned from "A" Agricultural Uses to "R-2" One-family Residence District; and that the County Clerk be and she is hereby ordered and directed to change the zoning map, to show the change in zoning classification:

That part of the South Half of Section 19,  
Township 37 North, Range 6 East of the Third Principal  
Meridian, described as follows: Commencing at  
the Southwest corner of the North Half of the  
Northwest quarter of Section 30, Township and Range  
aforesaid; thence South 86° 44' East along the South  
line of the North half of the North Half of said  
Section 30, 954.42 feet to the West line of the

East Half of the Norwest Quarter of said Section 30:  
thence North 2° 46' 36" East along said West line  
and along the West line of the East Half of the  
Southwest Quarter of said Section 19, 3094.91 feet  
to the original centerline of Frazier Road; thence  
South 72° 27' East along said center line 413.85 feet;  
thence South 68° 44' East along said center line  
and said line extended 1991.01 feet for the point  
of beginning; thence North 68° 44' West along said  
extension and said center line 291.84 feet; thence  
South 21° 16' West 290.40 feet; thence South  
68° 44' East 80.35 feet; thence North 88° 19' 53"  
East 524.43 feet to a line drawn South 51° 09'  
East from the point of beginning; thence North  
51° 09' West along said line 284.79 feet to the  
point of beginning; containing 2.35 acres; in  
the Township of Little Rock, Kendall County, Illinois.
