AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED

WHEREAS, Robert Hacker, did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and the ordinances of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted May 10, 1960,

and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed amendment on the 2nd day of February, A.D. 1971 on the site described in the petition and at the conclusion of said hearing said Zoning Board of Appeals voted in favor of recommending to the Board of Supervisors of Kendall County, Illinois that the petition be granted and the Zoning maps and ordinance be amended in the manner required by law.

NOW THEREFORE, BE IT ORDAINED by the Board of Supervisors of Kendall County, Illinois that the following described property be and it is hereby rezoned from "A" Agriculture to Special Use for Profit and that the County Clerk be and she is hereby ordered and directed to change the zoning map, to show the change in zoning classification;

That part of the Wouthwest $\frac{1}{4}$ of Section 34, Township 37 North, Range 6 East of the 3rd Principal Meridian, described as follows; Beginning at a point in the South line of said Section 34, that is 69.30 feet East of the Southwest corner thereof, thence North $39^{\circ} 41' 30''$ East, 874.85 feet to a point, thence North $49^{\circ} 39' 30''$ East, 120.80 feet to a point, thence North $81^{\circ} 20' 30''$ East, 83.18 feet to a point, thence South $87^{\circ} 00' 30''$ East, 285.07 feet to a point, thence North $70^{\circ} 42' 30''$ East, 80.87 feet to a point, thence North $16^{\circ} 07' 30''$ East, 87.10 feet to a point, thence North $2^{\circ} 28' 30''$ East, 553.52 ft. to a point, thence North $0^{\circ} 08' 30''$ East, 121.26 feet to a point, thence North $84^{\circ} 47' 30''$ East,


5.39 feet to a point, thence South $4^{\circ} 07'$ West,
1131.10 feet to a point in the northerly bank of the
Fox River, thence South $52^{\circ} 37'$ along said northerly
bank of said Fox River, 246.66 feet to a point, thence
South $34^{\circ} 37'$ West along said northerly bank of said
Fox River, 238.45 feet to a point, thence South
 $20^{\circ} 37'$ west along said northerly bank of said Fox River,
104.30 feet to a point, thence South $33^{\circ} 20'$ West
along said northerly bank of said Fox River, 78.30
feet to a point in the said South line of Said Section 34,
that is 1430.70 feet East of the point of Beginning
(measured along said south line of said Section),
thence North $88^{\circ} 44'$ West along said South line of
said Section 34, 1430.70 feet to the point of beginning,
in Little Rock Township, Kendall County, Illinois,
and containing 38.83 acres more or less.
