ORDINANCE 91-5

AMENDING KENDALL COUNTY ZONING ORDINANCE AS AMENDED

WHEREAS. Clarence C. Schoger and Joan A. Schoger, did petition the Zoning Board of Appeals of Kendall County for a public hearing in the manner required by law and the ordinances of Kendall County, Illinois for a proposed amendment to the Kendall County Zoning Ordinance adopted May 10, 1960 and

WHEREAS, said Zoning Board of Appeals did thereupon publish notice of a hearing on said proposed amendment to said Zoning Ordinance as provided by the Statutes of the State of Illinois, and did then hold a public hearing on said proposed amendment on the 26th day of February, A.D. 1971 on the site described in the petition and at the conclusion of said hearing said Zoning Board of Appeals voted in favor of recommending to the Board of Supervisors of Kendall County, Illinois that the petition be granted and the Zoning maps and ordinance be amended in the manner required by law.

NOW THEREFORE, BE IT ORDAINED by the Board of Supervisors of Kendall County, Illinois that the following described property be and it is hereby rezoned from "A" Agricultural District to "R-2" One-family Residence District, and that the County Clerk be and she is hereby ordered and directed to change the zoning map, to show the change in zoning classification:

That part of Section, 20, Township 37 North, Range 6
East of the Third Principal Meridian, described as
follows: Commencing at the most Easterly corner of
lot 8 of Unit one, Sugar Brook Estates; thence South
39° 54' 31" West along the Southeasterly line of said
Lot 8, 435.0 feet; thence North 50° 05' 29" West
along the Southwesterly line of Woodland Drive,
160.0 feet to the most Easterly corner of Lot 7 of
Unit One, Sugar Brook Estates; thence South 39° 54' 31"
West along the Southeasterly line of said Lot 7.

165.0 feet; thence South 78° 41' West along the South line of said Lot 7, 62.47 feet thence South 12° 05' 29" East, 418.36 feet; thence North 77° 54' 31" East, 123.0 feet; thence South 120 05' 29" East, 175.0 feet; thence South 62°00' East, 428.54 feet; thence North 48° 30' East, 195.86 feet; thence South 49° 55' 57" East, 670.08 feet; thence South 24° 54' 31" West, 24.34 feet; thence South 53° 09' 46" East, 666.16 feet to the center line of Little Rock, Creek; thence North 54° 04' East along said center line, 306.47 feet; thence North 80 37' 39" East along said center line, 1466.66 feet; thence North 450 00!
