City Offices: Cities incorporated under the Illinois Municipal Code shall elect a mayor, aldermen, city clerk, and city treasurer (with exception for city treasurer appointment in cities under 10,000 population). (65 ILCS 5/3.1-15-5)

Village and Incorporated Town Offices: In all villages and incorporated towns, there shall be elected a president, trustees, and a clerk, except as otherwise provided in this Code. (65 ILCS 5/3.1-15-5)
