ITEMS OF BUSINESS

- *Discussion of 2021 Kendall County Reapportionment* – Mr. Koeppel informed the committee about the GIS Redistricting Plans website, and said 2020 Census data has been delayed by the Federal Government. GIS Analyst Josh Carlson explained that The American Community Survey is a US Census program that tracks various population statistics on an annual basis. Every 5 years, they produce a thorough estimate based on their surveying efforts. The data I used was the ACS 2015-2019 set. Until the 2020 Decennial numbers come out, it is the most current picture we have of the county's population.

Mr. Carlson said that the problem with ACS data is that it's estimated at the block group level, as opposed to the census block level. Think "north side of town" as opposed to a specific neighborhood. It's useful as a starting point for a conversation, but at the voter precinct level, it's not reliable enough to know whether moving a single precinct will make the districts more or less balanced.

To produce the County's estimates, Mr. Carlson said he combined ACS population estimates with residential parcel data to try and identify "where" within a given block group the population is distributed. That way if a custom plan submission splits a block group, they can make a reasonable guess as to how many people fall on either side of the line.

Mr. Koeppel stated that the county can use the ACS survey data or use the 2010 Census data to create the redistricting plans. There has been substantial growth in certain areas of the county. Discussion on population data by voting precincts, and other filters that might be useful. Koeppel asked committee members to review the Select a Plan site at: <https://maps.co.kendall.il.us/redistricting2021>, create plans using the District Sketching tool, and using the ACS data as a 50/50 split. Any questions should be directed to Mr. Koeppel before the May COW meeting, who will then compile the list of questions and forward to the State's Attorney's Office for review. **Mr. Koeppel will have a draft plan and map for the May 13, 2021 Committee of the Whole meeting.**

QUESTIONS FROM THE MEDIA – Jim Wyman, WSPY News asked about the two district's populations, and asked if District 2 is growing faster in the past 10 years. MR. Wyman also asked about the July 1, 2021 deadline, and if all 102 State Counties are doing district reapportionment.

**A RESOLUTION APPROVING THE REAPPORTIONMENT PLAN FOR
KENDALL COUNTY, ILLINOIS**

WHEREAS, the Kendall County Board is required to reapportion Kendall County, so that each member of the Kendall County Board shall represent the same number of inhabitants pursuant to 55 ILCS 5/2-3002; and

WHEREAS, the Kendall County Board has determined that its members shall be elected from two districts pursuant to 55 ILCS 5/2-3003; and

WHEREAS, the Kendall County Board has divided Kendall County into two districts of approximately equal population; and

WHEREAS, the Kendall County Board has determined the Kendall County Board shall consist of ten members, with five members to be elected from each district; and

NOW, THEREFORE, BE IT RESOLVED BY THE KENDALL COUNTY BOARD, Kendall County Board considers the following to be its apportionment plan for the purposes of the Kendall County.

1. The Kendall County Board shall be elected from two districts, with five members to be elected from each district;
2. Voters will not have cumulative voting rights in the multi-member districts;
3. That the description of District 1 is provided in the attached Exhibit "A";
4. That the description of District 2 is provided in the attached Exhibit "B";
5. That District 1 and District 2 are illustrated in Exhibit "C";
6. Upon approval of the Kendall County Board, this plan shall be filed in the Office of the Kendall County Clerk.
