

Assignment of Out-of-Circuit Judge

On the request of Honorable Robert T. Hanson, Chief Judge of the Fifteenth Judicial Circuit, that a judge of another judicial circuit be assigned to hear Ogle County case *People of the State of Illinois v. Jose Ricardo Rodriguez*, Case No. 2003-CF-45, and the Supreme Court having determined that the public necessity so requires:
