CALL TO ORDER

Chairman Gryder called the Stormwater Oversight Committee Public Hearing to order at 4:00 p.m.

ROLL CALL

APPROVAL OF AGENDA

Member Hendrix made a motion, seconded by Member Prochaska, to approve the agenda as presented. With a voice vote of eight (8) ayes, the motion carried.

APPROVAL OF MINUTES

Member Hendrix made a motion, seconded by Member Cesich, to approve the minutes of the December 12, 2019, public hearing and meeting. With a voice vote of eight (8) ayes, the motion carried.

PUBLIC COMMENT

Mark Phipps, Redevelopment Coordinator for the City of Aurora, asked if Kendall County made any changes to the County's Stormwater Ordinance, would those changes prevent the City of Aurora from enforcing Kane County's Stormwater Ordinance inside the City limits. Mr. Asselmeier responded that, to his knowledge, municipalities in more than one (1) county may choose which county's stormwater ordinance to adopt. If Kendall County makes any changes to the Kendall County Stormwater Management Ordinance, those changes would not impact the City of Aurora's ability to enforce Kane County's Stormwater Ordinance inside Aurora.

Greg Chrisse discussed the complaint that he had previously submitted to Kendall County. Mr. Chrisse requested that the County amend the Stormwater Management Ordinance by establishing baselines to make the Ordinance enforceable and lower the three foot (3') threshold on

residentially used properties. He explained that a six inch (6") or twelve (12") inch changes in fill can have a huge impact on residentially used land.

OPEN OF STORMWATER MANAGEMENT OVERSIGHT COMMITTEE PUBLIC HEARING

Chairman Gryder opened the Stormwater Management Oversight Committee Public Hearing at 4:06 p.m.

Comments on Stormwater Management Related Regulations and Enforcement

The Committee reviewed the 2019 and 2020 survey responses from the townships.

At the end of July, the County mailed the annual NPDES survey to the townships. 2020 marks the second year of sending and receiving responses from the townships. Four (4) townships responded in 2020 compared to five (5) townships in 2019.

In summary, only Oswego Township utilized the stormwater information on the County's website. Only one (1) township utilized the volunteer opportunities page on the website. Electronics recycling was the most popular volunteer opportunity except in Oswego Township where river cleanups was the more popular volunteer opportunity. No illicit discharges were reported. The townships wanted the County to do more visual inspections and grab samples to identify and track illicit discharges. The results on training were mixed. Only Big Grove Township felt that necessary steps to reduce flooding was occurring.

The survey composite and comparison of 2019 and 2020 survey responses were provided.

Mr. Asselmeier noted that the County only has one (1) set of topographic data from the website which makes it difficult to enforce the Stormwater Management Ordinance when evaluating increased fill on properties. Scott Koeppel noted the expense of topographical flights and the recommendation to them every eight to ten (8-10) years. Member Kellogg explained the need to get topographic information after houses are constructed. Mr. Asselmeier explained the difficulties of getting measurements on private property. Member Kellogg asked if the three foot (3') rule is something the County can change. Mr. Asselmeier said that he would ask WBK if a change to that rule was possible. Chairman Gryder asked if this issue could be brought back to the Stormwater Management Committee in the future. Mr. Asselmeier responded yes or that the Planning, Building and Zoning Committee could research the matter and bring a proposal to the Stormwater Management Committee in the future.

Proposed Changes to the Kendall County Stormwater Management Ordinance

Mr. Asselmeier noted that the County Board approved a change to the definition of Bulletin 70 last year. He noted the that the Illinois State Water Survey officially changed the name of the document from Updated Bulletin 70 to Bulletin 75. WBK was confirming that no other changes occurred. After WBK completes their review, an amendment will be proposed correcting the official name of Bulletin 75. Staff does not have any additional proposed changes to the

Stormwater Management Ordinance at this time. No other proposed changes were presented by the Committee or members of the public.

Member Hendrix asked about stormwater drainage along Grove Road which is causing mud around nearby homes, bike path, and cul-de-sac. Mr. Asselmeier suggested discussing the matter with Fran Klaas; Mr. Asselmeier was unaware of a cleaning schedule for the ditches in the County.

ADJOURNMENT

Member Hendrix made a motion, seconded by Member Cesich, to adjourn the meeting. With a voice vote of eight (8) ayes, the motion carried. The Stormwater Management Oversight Committee adjourned at 4:21 p.m.

Re: 2020-2021 Items to Report

Since the October 2020 Stormwater Management Oversight Committee Hearing, the following stormwater related items have occurred:

- 1. The Planning, Building and Zoning Committee investigated lowering the height requirement that triggered a stormwater management permit from three feet (3') for developed areas of the County. The Committee decided against changing the requirement.
- 2. The 2018 contours were added to the GIS. The 2018 and 2010 contours are available for comparison on the GIS.
- 3. At the County's request, WBK investigated possible changes to the Stormwater Management Ordinance in response to FEMA Bulletin P-2140 Floodplain Management Requirements for Agricultural Structures and Accessory Structures. Their recommendation was no changes to the Ordinance were required at this time.
- 4. The Kendall County Board approved amendments to the Stormwater Management Ordinance pertaining to Bulletin 75.
- 5. The County prepared and submitted a new MS4 Five Year Plan.
- 6. At the end of July, the County mailed the annual NPDES survey to the townships. 2021 marked the third year of sending and receiving responses from the townships. Four (4) townships responded in 2021 and 2020 compared to five (5) townships in 2019. The responding townships in 2021 were Seward, Na-Au-Say, Oswego, and Lisbon. Only Seward utilized the County's website for stormwater information. None of the townships utilized the County website for volunteer opportunities. Electronics recycling and household waste recycling were the most popular volunteer opportunities suggested for future participation. All of the townships felt the County did an adequate job inspecting construction sites for soil erosion control. None of the townships felt the County was taking the necessary measures to reduce flooding.

The survey composite and comparison of the 2019, 2020, and 2021 survey responses are attached.
