<u>Call to Order and Pledge Allegiance</u> – Chair Judy Gilmour called the meeting to order at 3:00p.m. and led the Pledge of Allegiance.

Approval of Agenda: Member Cesich made a motion to approve the agenda, second by Member Rodriguez. **With five members present voting aye, the agenda was approved.**

<u>Approval of Minutes</u> – Member Koukol made a motion to approve the February 28, 2022 meeting minutes, second by Member Cesich. <u>With five members present voting aye, the motion carried by a 5-0 vote</u>.

Public Comment – None

Status Reports

Coroner – Written report provided. Coroner Purcell reported a total of 31 deaths in the month of February, with 2 suicides and 29 natural.

Coroner Purcell stated that the full-time Deputy Coroner position was approved by the Board earlier in the month, and that the deadline for application submission will end soon. They have received approximately 25 applications thus far, and hope to conduct interviews next week. Purcell hopes to have a start date for the new position of May 1, 2022.

Coroner Purcell informed the committee of her office's participation in the Drug Enforcement Administration (DEA) **Takeback Day** Event on Saturday, April 30th from 10am – 2pm. in front of Coroner's Office at 804 John Street, Yorkville.

The event is to encourage and educate the public about the importance of disposing of any unwanted, unused or expired prescription medications, needles, etc. in their household. The Coroner's Office partners with local law enforcement agencies in this effort. Drive-thru drop-off is available for citizens as well.

EMA – <u>Written report provided</u>. EMA Director Bonuchi reported that work continues on the Mitigation Plan. The draft agreement has been sent to the State's Attorney's Office for review, and the contractor is currently working on the FEMA GO application.

Bonuchi stated they are currently conducting the Amateur Ham Radio Operator 13-week course, with 6 students participating. Once they are certified, they qualify to become storm spotters.

Bonuchi also reported that he has been working with Facilities Management on renovation of the EMA Command Post, and will keep the committee updated on the progress.

Public Defender —Assistant Public Defender Chris Wheaton introduced himself to the committee, and reported that former Kendall County Assistant Public Defender Jessica Deets has been rehired by the office and will begin in the next few weeks.

Circuit Clerk – <u>Written report provided.</u> Chief Deputy Circuit Clerk Lynn Cullick reported their office is down five employees, including 3 supervisors. Discussion on the ongoing turn-over in the office, mostly due to the amount of work required, and the low pay offered.

Court Services – Written report provided. As part of the Court Services/Probation Department's continued efforts to highlight existing programming, Director Elliott highlighted the Juvenile Delinquency Diversion Program. Elliott stated that the Diversion Specialist Probation Officer position is reimbursed 100 percent by the Administrative Office of Illinois Courts, and the police municipalities funds the benefit portion of that position.

A juvenile diversion is a means by which the office tries to take as many opportunities to divert youth away from the judicial court system. They know that when they hold youth accountable for their behavior without resorting to legal sanctions or court oversight or the threat of confinement that there is a 45 percent of participants are less likely to reoffend once they are in the program. Having a skilled Diversion Specialist to work with them can help to decrease the recidivism by 10 percent more.

The process begins when a police department sends a referral to Court Services when a youth is charged with an alleged offense, Court Services then meets with the State's Attorney's Office to review all of the police reports, determine if it is an offense, the nature of the offense, the age of the youth, and next steps.

If a youth is diverted, assuming that the SAO would prosecute, and the youth is cooperative with the process, the youth and their parent are invited to a preliminary conference where information is gathered, explaining what diversion is, accepting responsibility for the offense, issues and a contract for participation in the program, buy in from the parents, and next steps.

Presiding Judge – Judge Pilmer reported on a collaboration of the Special Courts Coordinator, Court Services Director, the Judicial Office, and local law enforcement agencies, they recently hosted a Symposium to answer questions on Mental Health Issues that were identified by the Supreme Court.

Judge Pilmer reported that the Supreme Court has indicated they want remote proceedings, hybrid and in-person proceedings. This is a benefit to the public attorneys, State's Attorney's Office and Public Defenders Office. They might have to invest in updating technology equipment in the future.

Judge Pilmer stated that on Friday, March 25, 2022, the Supreme Court issued an order with time standards for case closure in Illinois Trial Courts, setting guidelines for moving cases to a conclusion for every case category. This will require more reporting by the Circuit Clerk's Office, but will benefit the Court System. This involves cases filed after January 1, 2022, but will take effect on July 1, 2022.

Lastly, Judge Pilmer informed the committee that his office was awarded a \$237,000 Technology Modernization Grant through the Illinois Courts. This grant will allow the purchase of new hardware, equipment and updates for the Court rooms.

State's Attorney – No Report

Sheriff's Report -

a. Operations Division – <u>Written report provided</u>. Commander Langston reported that all Command Staff are now wearing Body Cameras as mandated.

Langston also informed the committee on updates to the Sheriff's Office Transparency Dashboard webpage for public use which includes month-end statistics, Heat Maps, Demographics, Incidents, Citations, and Arrests.

Commander Langston reported that they recently hired 5 new deputies, and to assist with replacement of retiring deputies, Sheriff Baird stated that the Merit Commission would have to approve expedited testing to decrease loss of candidates and lateral hires.

b. Corrections Division – <u>Written report provided</u>. Commander Russo reported an increase in medical appointments and expenses.

Russo announced that a new EHM Clerk has been hired and currently in training with EHM personnel.

Commander Russo also reported that inmate transports have increased with the opening of the courts, medical facilities, and dental facilities.

c. Records Division – Written report provided.

• Discussion and Approval of Court Services Grant Budget Revision - Director Elliott reported that the Family Violence Coordinating Council for the 16th and 23rd Circuit is nearing the end of their fiscal year. The Court Services Office has requested a budget thorough the ICJIA. The revision does not change the total budget amount, but simply changes the categories (line item) amounts.

Member Cesich made a motion to approve the request for the grant budget line item revisions, second by Member Koukol. With five members present voting aye, the motion passed by a 5-0 vote.

- Approval for the Sheriff's Office to issue an Invitation to Bid for Jail Food Service

 Undersheriff Richardson stated that the current Food Service vendor has informed the Sheriff's Office that they can continue jail service, but at an increase of 20 percent. Richardson stated that the Sheriff's Office is seeking Committee approval to go out for bid of Jail Food Service.

 Member Cesich made a motion to approve the request to bid, second by Member Rodriguez. With five members present voting aye, the motion carried by a vote of 5-0.
- Approval of the Gateway Foundation, Inc. and the Kendall County Problem
 Solving Courts Agreement Judge Pilmer said that this is an annual agreement for
 the Drug and Veterans Courts. Discussion on the use of other insurances,

Items Worthy of notice to the County Board:

Detention costs have been high this year as noted above. We anticipate having exhausted the budgeted amount by the end of the summer. One of the challenges with youth being detained for longer periods of time has been youth being dually involved with DCFS and the lack of appropriate housing for them through DCFS. These extended stays in detention due to DCFS involved youth it not unique to Kendall as many counties in the state have struggled with this. Jacqueline Juodis, the juvenile supervisor, has been working with DCFS to provide an in-service training regarding Dually Involved Youth on July 28th at noon in the Jury Assembly Room of the Courthouse. County Board members are invited to attend. The goal of this meeting is to gain a greater understanding from DCFS as to why placement is a problem, share our perspective and work collaboratively toward a solution. Additionally, this past December we launched our collaborative Enhanced Probation Services Program with Family Counseling Services to target the families with high likelihood of detention due to identified risk factors or those that have demonstrated repeat detentions. It has been a slow start but we are progressing and have seen some improvements with a few of the youth. We hope to see repeat admissions decrease over the rest of this year as we continue to develop and hone this program.

July 17-23, 2022 is National Pretrial, Probation and Parole Supervision Week. Throughout the nation there are over 5 million adult and juvenile offenders on some form of community based supervision. In

order to effectively and safely monitor these individuals, officers must utilize their extensive and specialized training, skills and talents to guide long term behavioral change in these individuals. The field and our society is ever changing and evolving and we must also evolve with it. Here in Kendall County, we pride ourselves on striving to be the best of the best. We research the best approaches and train to master them, with the goal of promoting safer communities for everyone. The personnel we have are some of the most dedicated, ambitious and knowledgeable individuals I have come to know. They have a passion for the work and strive to do right by the court, the client and the community. It is with this in mind that I ask this committee to recommend to the full board that July 17-23rd be designated as Pretrial, Probation and Parole week in Kendall County.

The Probation Department will be continuing our efforts to highlight existing programming and services we provide to clients under our supervision. As a reminder, our mission is to "serve the community by promoting positive behavioral change utilizing proven methods to increase public safety". All of our programs and services are designed to be in alignment with this mission. This month Bruce Ludwick, our Community Service Work Coordinator will be highlighting the benefits of our Community Service Work Program. A request is made for board members to refer known nonprofits to us for consideration of becoming one of our worksites.

RE: Non-Binding Advisory Question for November 6th Ballot

Possible Advisory Question:

Should the Illinois Governor be able to use emergency powers indefinitely in order to override other elected officials? [YES] or [NO]

August 22, 2022, is the last day to adopt a Resolution or Ordinance for binding or advisory public questions, including for county, municipal, school, township, and park boards to adopt specifically authorized advisory public questions. (10 ILCS 5/28-2(c)).

Staff is neutral on the proposed advisory question.

If the committee would like to add an advisory question to the ballot, the full County Board needs to approve a Resolution. If the committee votes in favor, Administration the State's Attorney's Office will work together on a Resolution.

COUNTY OF KENDALL, ILLINOIS Ordinance 22 -

Ordinance Establishing the Judicial Facilities Fee and the Judicial Department Facilities Construction Fund

WHEREAS, Kendall County (population 131,869) was the fastest growing county in the United States from 2000 to 2010, and the fastest growing county in Illinois from 2010 to 2020, having grown its population by 141% since 2000; and

WHEREAS, the current courthouse cannot accommodate the need for additional courtrooms, and the courthouse second floor was not built with plumbing accommodations and security features required of a modern facility. To design and build-out the second floor of the current courthouse, the County of Kendall needs to generate additional revenue from various sources; and

WHEREAS, the Kendall County Board, believes that the users of the court facilities should directly contribute to construction of new judicial facilities; and

WHEREAS, Public Act 102-1021 amended 55 ILCS 5/5-1101.3 to include the County of Kendall; and

WHEREAS, the County of Kendall is authorized pursuant to 55 ILCS 5/5-1101.3 of the Illinois Compiled Statutes to impose a Judicial Fee to be used for the costs associated the building of new judicial facilities; and

NOW THEREFORE BE IT ORDAINED by the Kendall County Board that the Kendall County Board confirms the establishment of a Thirty Dollar (\$30) fee to finance new judicial facilities to be paid as follows: 1) in civil cases, the fee shall be paid by each party at the time of filing the first pleading paper or other appearance; provided that no additional fee shall be required if more than one party is represented in a single pleading, paper, or other appearance; (2) In felony, misdemeanor, local or county ordinance, traffic, and conservation cases, the fee shall be assessed against the defendant upon the entry of a judgment of conviction, an order of supervision, or a sentence of probation without entry of judgment pursuant to Section 10 of the Cannabis Control Act, Section 410 of the Illinois Controlled Substances Act, Section 70 of the Methamphetamine Control and Community Protection Act, Section 12-4.3 or subdivision (b)(1) of Section 12-3.05 of the Criminal Code of 1961 or the Criminal Code of 2012, Section 10-102 of the Illinois Alcoholism and Other Drug Dependency Act, or Section 10 of the Steroid Control Act; (3) In local or county ordinance, traffic, and conservation cases, if fines are paid in full without a court appearance, then the fee shall not be imposed or collected.

BE IT FURTHER ORDAINED that said funds shall be collected by the Kendall County Circuit Clerk and deposited into the Judicial Facilities Construction Fund.

BE IT FURTHER ORDAINED, The proceeds of all fees enacted under this Section must be deposited into the county's Judicial Department Facilities Construction Fund and used for the sole purpose of funding in whole or in part the costs associated with building new judicial facilities within the county, which shall be designed and constructed by the county board with the concurrence of the Chief Judge of the applicable judicial circuit or the presiding judge of the county in a multi-county judicial circuit.

BE IT FURTHER ORDAINED, that this ordinance shall become effective on ASK COMMITTEE.

Sheriff Baird,

After a thorough review of the 4 respondents to the invitation to bid (ITB) previously posted, I am recommending that the Kendall County Sheriff's Office and the County of Kendall select Aramark as the food service provider. Aramark's proposal meets all of the specifications required in the ITB, and were the lowest responsible bidder.

Aramark offers a robust training program which assists returning citizens in gaining employment upon completion of incarceration. In addition, Aramark offers a scholarship program which could benefit both those incarcerated and their family members. This program will improve the lives of the citizens of Kendall County. Aramark's cost over the 39-month term of the contract is \$35,436.65 higher than the bid received from Summit if the Consumer Price Index (CPI) does not exceed 10%. Aramark's bid lists yearly price increases at the food away from home CPI or 10%, whichever is lower, whereas Summit will increase the amount of the CPI. With the quickly rising CPI, it is impossible to predict if the Summit price would rise more than 10% in future years. Additionally, Summit requires a minimum of 5-8 inmates working in the kitchen during each shift. The Kendall County Jail often does not have access to 5-8 inmates that are appropriately screened and approved to work in the kitchen. The cost implications of not providing sufficient inmate labor, as required in the proposal, is unknown.

The number of unknown price factors in the bid from Summit when weighed against the numerous benefits of the program offered by Aramark, clearly make Aramark the lowest responsible bidder.

The attached table further details this recommendation and includes a cost analysis of the 39-month term of the contract.

- 4) Aramark is the lowest responsible bidder due to caps on future increases and the added value of inmate education and scholarships.
