#### **Items of New Business**

- ➤ Training on ReMarkable Tablets Jennifer Karales provided training for the Board members on the new ReMarkable Tablets which occurred on August 11, 2022 at the Committee of the Whole (COW).. Mr. Koeppel's vision is that all agendas could be put on the tablet in the future. The tablets were purchased for the all Board Members.
  - > FY 22-24 American Rescue Plan Act (ARPA) Budget Discussion

Mr. Koeppel directed members to review the handout for Kendall County ARPA Expenses for FY 22-24.

Mr. Koeppel led the discussion on the application for funds by Kendall County 211 Inc. He stated that other adjacent counties have United Way set up but Kendall

County does not. This service will allow more control for services, set-up purposely as a non-profit. There is no start date determined as this still needs approval before going live. Discussion that 988 used for mental health only, 211 will provide more services to the citizens.

Member DeBolt made a motion for the application of Kendall County 211 be sent with a request to the State Attorney's office to draft a Grant Agreement and then forwarded to the County Board Meeting for approval, second by Cesich. With five members present voting ave, the motion carried 5-0.

Discussion continued on other ARPA applications. Boulder Hill reduced their initial \$6 million request to \$3 million. ,. There has been no formal request by the Drainage District.

Newark- Water Filter and Kendall Township is at the States Attorney's office for review

Judge Presentation – Scott Koeppel had a discussion with the Judge on presentation costs. \$255,000 is a rough number.

Scan Documents discussion- Mr. Koeppel stated that IT has not started this project, as it wasn't in the budget. If in the budget for next year IT could buy the software and get started. If ARPA funds are used, more information could go on the website and would be more accessible to the public. Money would be used to hire professional services to handle the scanning process and more scanners purchased for employees to scan more documents, not just vouchers.

Revisit non-profit grants – A committee member asked Jennifer to reach out to the Legion.

Oswego Water project – on hold.

When asked, Mr. Koeppel said they are still taking requests from other municipalities.

Member Cesich asked if this is the full \$24 million ARPA amount. Mr. Koeppel said this is what is left over after loss revenue portion taken out. Approximately \$9 million taken out for capital improvement projects and loss revenue.

When asked if ARPA funds went to the school districts, and if they can ask for funds through Kendall County. Mr. Koeppel said they did receive ARPA funds, but could still apply for funds through County.

In January of this year a corporation was formed, **Kendall County 211 incorporated (Kendall 211)**, as a not-for-profit based in Kendall County. For example, mortgage, rent, and utility assistance, food, emergency sheltering, health care, counseling support groups, transportation, disaster assistance, etc. The service is available 24 hours a day seven days a week to any resident dialing 211 from a landline, cell phone, or by texting.

In February of this year Kendall 211 had its' first board meeting, proposed and adopted bylaws and elected the following members to the Kendall 211 board; Lynette Bergeron – Ken Com Director, Scott Gryder – Chairman Kendall Cty Board, Grant Wegner – Secretary At Large, Larry Nelson – Treasurer At Large, Liz Holmberg – 708 Board Kendall, Matt Kellogg – Kendall County Board Member, Bob Pilmer – Judiciary, Troy Parlier – Oswego Mayor, John Purcell – Yorkville Mayor, Mike Rennels – Plano Mayor, Lynn Cullick – Kendall Health Board, Chris Mehochko – Regional Supt Kendall Schools, and Stephanie Wayne – Director County NFP YMCA.

Board members then voted in favor of Kendall 211 becoming a 501c3 corporation and to allow a contract to be negotiated with PATH a not-for-profit call center provider in Illinois that houses the database of community services available to Kendall County residents, and to answer the 211 calls 24 hours a day, seven days a week.

# Kendall County, IL Proposed Phase 2 Scope of Work Grant Services August 23, 2022

Lit Communities proposes to continue working with Kendall County in Phase 2 to support its strategy and implementation of recommendations with respect to proactively evaluating, applying for and obtaining funding from applicable broadband State and Federal programs. To accomplish this objective, Lit will perform the following grant services for Phase 2:

- Identify new and upcoming federal and state grant funding opportunities that were not included in the Strategic Plan at the time of publishing
  - Review Notices of Funding Opportunity and project application solicitations to identify all relevant information including due date, matching, special requirements and timeline.
- Maintain the short-list of primary grant programs and respective application timelines to match against project funding needs (i.e. Middle Mile rings, FTTH pilots, unserved/underserved, etc.)
- Grant preparation for two (2) priority applications (one state and one federal) identified by Kendall County, including; confirming project area eligibility, development of project scope of work, preliminary cost estimates, project narratives, and application components. For aspects that involve information from the County (DUNS number, SAM.gov registration, etc.) we will coordinate with the County to obtain this information. Lit will also work with a point of contact designated by the County to provide all pertinent documents, files and instructions for the submittal of grant applications
- Participate in webinars and pre-application presentations conducted by the state or federal funding agencies
- Coordination with Kendall County and respective state and federal agencies to request pre-application meetings to discuss project eligibility, scope, and questions regarding specific programs and application requirements.
- Coordination with the project team regarding the preparation/assembly of required documentation such as; Engineering Feasibility Reports, NEPA Checklists, Financial Projections and Proforma, Network Diagrams, etc.
- Assist Kendall County with a public support effort, i.e. develop templates for Letters of Support, key stakeholder briefings, social media posts, etc.
- Coordination with Kendall County's designated grant contact regarding application submission
- Following application submission, monitor agency developments and updates regarding agency review and approval of proposals (i.e. monitor monthly meetings, public updates, etc.)



- Assist Kendall County with any follow-up requests for additional information regarding the grant application, including review of information requested, clarifications (if necessary), and response within the identified timeline.
- If awarded, assist Kendall County with the review of grant funding agreements and assist with any questions or clarifications needed prior to execution of the contract with the respective funding agency.
  - Lit will incorporate the respective Grant Administrative costs in each grant application and budget, as allowed, and coordinate with the County on any monitoring, reporting and/or administrative aspects that can be handled by the County or through Lit Communities through a separate Grant Administration agreement for the respective grant.

#### Length of Agreement:

Since the specific grant opportunities and applications have not been released yet, Lit
Communities will work with the County on pre-application activities beginning on the date
of contract execution and will be considered complete once the grant application has
been submitted to the respective agency(ies).
