Call to Order- Shawn Flaherty called the meeting to order at 3:33pm on Friday April 8th, 2022.

Shawn asked for some clarity on these amendments and what we are changing, and Bobby Richardson responded that these changes being requested are for testing procedures moving forward. They would like to test more frequently as slots become available. In the lateral transfer verbiage, they wanted to change the time frame of when applicants were able to retest again. Shawn asked why we were looking to do a third process in the academy. Bobby responded that academy slots are so difficult to get sometimes, and these lists are shorter and having a harder time finding qualified candidates. We thought we could improve the number of candidate's and quality of candidate's if we change some of these procedures that we had in place previously. Tracy Page clarified, that moving forward they will operate off one list or the other, if we have slots available, we will be testing for academy and if by chance we were full staff we

would just create an eligibility list in case a position would open. We would not run an academy eligibility list and an 18-month eligibility list at the same time. Bobby Richardson commented that our goal is to fill all our positions off this individual testing process and academy slot and once those are full then we will test with the large test and 18-month list.

Motion to approve the lateral transfer procedure unamended as presented and the appointment procedure as amended per our discussion by Rob Delong, Second by Shawn Flaherty. All in favor, motion passes.
