Action After Closed Session – Gomez made a motion to forward the budget to the Executive Board, seconded by Gomez. All five members present voting aye. Motion carried.

DeBolt made a motion to approve and move forward to the Letter of Understanding to the Executive Board, seconded by Flanders. All five members present voting aye. Motion carried.

Other New Business – DeBolt reported the County Board will not sell the land to KenCom for a second tower but will give KenCom the land for a second tower if they have a diagram of the distance and space needed. They will then put in their master plan with the architect so it does not interfere with any future products that are coming.
