Courtroom 116 - All AD, EV, FC, GR, JV, JA, JD, and PR cases; CH cases (Mechanics Liens only).

Miscellaneous Notes:

1. All matters set on the hour for 9:00 a.m., 10:00 a.m., and 11:00 a.m.; or on the half-hour beginning at 8:30 a.m. for CR 114 are set by the Clerk or arresting agency. ALL OTHER TIMES ARE ONLY SCHEDULED BY THE COURT, with the exception of the Tuesday afternoon Juvenile Call and Detention hearings which shall be at 11:00 a.m. in CR 116 (J. Gleason) as necessary.
2. All ODD-numbered divorce/family cases are assigned to Judge McAdams in CR 111 and all EVEN-numbered divorce/family cases are assigned to Judge Voiland in CR 112.
3. Orders of Protection and Emergency Motions shall be heard by the Judge assigned to conduct weddings on that respective day; *except* Orders of Protections which are associated with another court file shall be heard by the judge assigned to that matter, or that court call (*e.g.*, CM cases heard by the CM judge, CF cases heard by the CF judge, and D/F cases by the judge assigned to the D/F case).
4. Dissolution of Marriage prove-ups are at 1 p.m. M-F (*excluding* jury weeks) in CR 111/112 (Judge McAdams/Voiland).
5. Class 3 and 4 Retail Theft Offenses and Class 4 Driving While License Revoked Offenses are set in CR 114 on Tuesday afternoons and Friday mornings.
6. TR/CM Judge may be assigned other cases (Prove Ups, and SC/LM Trials) by the Presiding Judge during the 5th week of each month.
7. Shelter care hearings to be scheduled by the Court as necessary.
8. Bond call shall be M-F at 1:00 p.m. in CR 114.
9. All TR/CM cases to be set for trial/hearing on Officer's key date.
10. Criminal Forfeitures shall follow the underlying criminal or traffic matter, if any.
11. Expungements shall be heard by the judge currently assigned to hear the case types from which the request for expungement originated.
12. The final jury trial status for all *criminal cases* shall be heard in CR 115 at 1:00 p.m. on the Wednesday preceding the first scheduled jury week of any given month; the final jury trial status date for all *civil cases* will be heard on the same date and at the same time in CR 113.
13. In months where two jury weeks are scheduled, only two judges will be assigned for each respective week. Judges are assigned on a rotating basis as set forth by administrative order designating future jury weeks.
14. No matters shall be scheduled before the judges assigned to conduct jury trials during their respectively scheduled jury weeks, without leave of court.
