- B. Presentation: Broadband Assessment and Grant Progress Jessica Fowler Lit Communications – Jessica Fowler, Lit Communities Chief Market Deployment Officer, and Rene' Gonzalez, Lit Communities Chief Processing Officer; presented to the commission the history of Lit Communities, counties they have/are currently working with and updated the commission of the study for Kendall County. Available grant funding and partnership options were also discussed.
- C. Update: Request for Proposal Public-Private Partnership in Providing Fiber to Home and Internet Services Matt Kinsey Director Kinsey reported to the commission the RFP is still in review with the State's Attorney's Office. Once legal is completed the Chairman will be notified and the process will begin to post the RFP publicly.

Chair Bachmann also informed the commission that he is meeting with Representative Underwood's office on Thursday to discuss the progress of the Commission thus far.
