OFFICIAL RESULTS

CANDIDATES IN GREEN ARE DECLARED WINNERS

A winning write-in candidate in the general primary election who receives the required number of votes at the primary must file a Statement of Candidacy, receipt for the filing of the Statement of Economic Interest (exception for federal and party offices only) and an optional Loyalty Oath. These forms must be filed within 10 days of the canvass and be filed with the certifying officer or board. For example, winning write-in candidates for Precinct Committeeperson will file with the County Clerk. (10 ILCS 5/7-60)
