Observations:

1. In the Basement, the base coat primer is being applied to walls and ceilings in Elec 003A Mech 003B.

2. At the Elevator, CMU masonry fill has been installed at steel beam per field coordination.

3. In Break Room 108, plastic lockers have been installed.

4. In Lobby 101, decorative pendant lights have been installed with cord centered as coordinated.

5. In Lobby 101, seams have been infilled with epoxy for resin in preparation for resinous terrazzo.

6. In Work Room 119, Bradford systems mailbox unit has been partially installed.

7. Aluminum fascia trim appears to be bent and warped on Northwest corner where replaced.

8. At Mech Area, 150 kw electrical generator appears to be installed.

9. The cast stone columns and pedestal at entry way appear to be installed.

Items to Verify:

- 1. In Stair 0A, verify door clearance of 18" from interior side of jamb to face of return rail is maintained.
- 2. In Staging/Work Area 106, verify counter depth is 2'-6" per detail 7/A8.8.
- 3. At Clerk, Recorder and Voter reception areas, verify all internal electrical runs are coordinated.
- 4. At Northwest corner, verify water is not accumulating due to incoming water line.
- 5. At North and South sides of entry, verify soffit vent is installed per detail 4/A6.4.
- 6. A cast stone jamb is damaged on North and some areas on West are chipped, verify repair.
- 7. Architect to verify locations of cameras with security contractor.

Information Or Action Required:

- 1. In Stair 0A, the sprinkler line valve extends past the gypsum finish, confirm if this will conflict with access panel installation. Can this valve be adjusted?
- 2. In the barrel vault, decorative wood trim mock-up was reviewed in field. No exception is taken to trim mock-up, confirm interior corner cuts are precise and finished to prevent separation.
- 3. For Door 100A and 100B, provide protection at base of door and around handle to prevent potential damage, for the duration of construction.
- 4. In Work Room 119, there is minor de-lamination at the top of the cabinet in south west corner. Repair.
- 5. At Southeast corner, soffit cut around light fixture is larger than fixture. Replace soffit piece.

Background and Discussion:

County Office Building #2 (802 S. Main Street) is on target to be completed by June 3rd. Cordogan Clark's detailed report of April progress is attached.

Contingency reduction 8A includes costs for expanding the current intrusion panel to support panic pull stations.

Contingency reduction 8B includes 1) costs to protect new carpeting/surfaces & safety fencing, 2) survey of east parking lot elevations for A/E, and 3) cost to sandblast and apply two coats of powder coating finish to ramp handrails.

The total request for Contingency Reduction 8A & 8B is \$17,348, with revised contract amounts as follows:

Lite Construction: \$2,181,793 (\$4,812 increase)
 Merit Corp: \$1,511 (\$1,511 increase)
 O'Malley Welding: \$21,280 (\$4,480 increase)

The current available contingency is \$136,103.
