Miscellaneous Notes:

2. OP cases with D/F cases are to be heard by the D/F Judge assigned to that case.
3. OP cases with CF cases are to be heard by the CF Judge.
4. Prove Ups are at 1 p.m. M-F (including jury weeks ) in CR 111/112 (Judge Voiland/ Krentz).
5. All jury trial settings are to be heard in CR 113.
6. TR/CM Judge may be assigned other cases (Prove Ups, and SC/LM Trials) by the Presiding Judge during the 5<sup>th</sup> weeks of each month.
7. Detention hearings to be set at 11 a.m. as needed in CR 116 (Judge Barnhart).
8. Shelter care hearings to be scheduled by the Court.
9. Bond call shall be M-F at 1:00 p.m. in CR 113 ( Judge McCann).
10. All TR/CM cases to be set on Officer’s key date.
11. Criminal Forfeitures shall follow the underlying criminal or traffic matter, if any.
12. No matters shall be scheduled before Judges Pilmer /McCann on the Mondays and Tuesdays or Wednesdays of jury week without leave of court.
13. OP’s and Emergency Motions shall be heard by the ADMIN Judge on their respective Admin morning.
