Flanders called for Old Business:

Investment for KenCom CD's – Flanders stated KenCom's CD's are maturing before the next Finance Meeting and the Committee needs to decide how they want to reinvest them. Discussion ensued. Jensen made a motion to invest \$1,000,000 in a 6-month CD at 4.39%, \$1,000,000 in a 9-month CD at 4.13%, and \$6,000,000 (in individual \$1,000,000 CD's) in 12-month CD's at 3.87%, seconded by Bastin. A roll call was taken with all four members present voting aye. Motion carried.

Flanders called for New Business:

Replacement of Finance Committee Chairman – Jensen made a motion for Josh Flanders to become the Finance Chairman and Dwight Baird to become the Finance Vice Chairman, seconded by Bastin. Discussion. All members present voting aye. Motion carried.

KenCom Credit Cards – Bergeron stated KenCom's credit cards were opened with a 2% cash back and only Larry had the authority to increase the line when needed for large purchases. There was discussion to create a purchasing policy for KenCom, and in the future bring all large purchases to the Finance Committee for prior approval. After discussion, it was discussed to have Jill Ferko gain access on KenCom's cards so she can view the credit cards and increase them as needed for large purchases.
