#### **New Committee Business**

A. Intergovernmental Agreement between the Village of Montgomery and the County of Kendall to Administer the County's Ordinance for Zoning, Building Code, Comprehensive Plan, Subdivision Control, and Stormwater Management within the Jurisdiction of the Village of Millbrook for a Term of Four (4) Years in the Amount of \$1.00 Annually Plus the Associated Costs Paid by the Village of Millbrook to the County of Kendall

The agreement between Kendall County and the Village of Millbrook is set to expire in August. Since August 2023, there have been about ten inspections in Millbrook, and there was one minor tweak to a special use permit at the Yogi Bear Campground. The proposal bumps up the contract term from one year to four years, as mentioned in Paragraph 8. Millbrook's annual payment to the County will stay the same, as outlined in Paragraph 3. The thirty-day early termination option will also remain the same, according to Paragraph 9. The Village of Millbrook gave the thumbs up to the Agreement at their meeting on July 23, 2024.

Member Shanley made a motion to forward to the next County Board, Seconded by Member Bachmann. With seven (7) members present voting aye, the motion was carried by a vote of 7-0.

B. Five-Year Leasing Agreement with Pitney Bowes for Mail Processing Equipment at County Office Buildings

An additional Mail Machine is needed in the new County Office Building located at 502 S. Main Street for use by the Clerk, Recorder and Election departments. The lease for the current Mail Machine located at 504 S. Main Street ends in September 2024. This new lease will cover both units.

Member Gengler made a motion to forward to the next County Board, Seconded by Member Rodriguez. With seven (7) members present voting aye, the motion was carried by a vote of 7-0.
