Kendall County Sheriff's deputies responded to a property damage accident in the area of Seneca Drive and Hampton Road within Oswego Township. 40 year old Dana Poss of the 100 block of Leisure Lane of Oswego was traveling westbound Hampton Road, and lost control of her vehicle while turning southbound onto Seneca Drive.
