Shall the Troy Fire Protection District, Will and Kendall Counties, Illinois, be authorized to levy a new tax for firefighters' pension	YES
purposes and have an additional tax of .2% of the equalized assessed value of the taxable property therein extended for such purposes? (1) The approximate amount of taxes extendable at the most recently extended limiting rate is \$4,573,822.77, and the approximate amount	NO
