Kendall County Sheriff's Office Arrests 11 in Warrant Sweep

On March 19th 2019, the Kendall County Sheriff's Office organized a multi-jurisdictional arrest warrant sweep throughout Kendall County. Multiple agencies assisted in the warrant sweep including the Plano Police Department, Yorkville Police Department, Oswego Police Department, Montgomery Police Department and the United States Marshals Great Lakes Regional Fugitive Task Force. A total of 11 warrant arrests for various offenses were made which are listed below.

- Kevin Bryant, 40 year old male from the 500 block of W. Kendall Drive in Yorkville, wanted for Unlawful Use of Credit Card. Bryant also fled officers during the warrant service which resulted in an additional charge of Obstructing a Peace Officer.
- Martin Huerta, 37 year old male from the 400 block of Grapevine Trail in Oswego, wanted for failing to appear on a Driving while License Revoked charge.
- Manuel Madrid, 23 year old male from the 2300 block of Titus Drive in Yorkville, wanted for failing to appear on a Domestic Battery charge.
- Adrian Herrera, a 23 year old male from the 500 block of S. Hugh Street in Plano, wanted for failing to appear on a Possession of Cannabis charge.
- Alesia Eddleman, 50 year old female from the 1300 block of Marketplace Drive in Yorkville, wanted for failing to appear on a Driving while License Suspended charge.
- Taylor Snyder, a 24 year old female from the 300 block of Mulhern Court in Yorkville, wanted for failing to appear on a Driving Under the Influence charge.

- Jeremy Hammond, a 39 year old male from the 100 block of 3rd Avenue in Montgomery, wanted for failing to appear on a Residential Burglary charge.

The public is reminded that criminal defendants are presumed innocent until the government is able to prove its charges in court beyond a reasonable doubt.
