For the voting publics convenience the Office of the Kendall County Clerk is providing the following information pertaining to the upcoming Consolidated Election. It is not intended to be an exhaustive listing.

Consolidated Elections are held in odd-numbered years. Voters will be provided an opportunity to vote for positions which may include: Municipal offices such as Mayors, Clerks, Treasurer, Trustees or Aldermen; Township offices and Assessors, Park District Commissioners, Public Library District Trustees, Fire Protection District Trustees (if elected), School District Boards, Regional Board Of Trustees, Community College District Trustees and other special purpose districts as required.

Properly filed and certified Referenda will also be placed on the appropriate ballots.

January 07	Last day to file petition for referenda (Referenda that can be initiated by petition)
January 22	Last day for adoption of a resolution or ordinance allowing a public question to appear on the ballot
January 31	Last day for local election officials to certify candidates to the election authority
February 07	Last day to file a notarized Declaration of Intent to be a Write-In Candidate with the County Clerk
February 28	First day for a registered voter within the US who expects to be absent from their county of residence on Election Day to make application for an official ballot
March 12	Last day for voter registration, except at the County Clerk's Office
March 13	First day for Grace Period registration & voting in the Offices of the Kendall County Clerk, 1 st floor, Rm 103
March 18	First day for In-Person Absentee Voting at the County Clerk's Office
March 20	Last day for an employee to provide written notice to their employer that they will be absent on Election Day to serve as a Judge of Election
March 25	First day for Early Voting at the County Clerk's Office & the Oswego Village Hall
March 26	Pollwatcher** & Candidate credentials available (**Organizations seeking such credentials must properly qualify for same and have registered the names and addresses of its principal officers with the Election Authority at least 40 days prior to the election. All pollwatchers must be registered to vote in Illinois)
April 04	Last day for Early Voting at the Oswego Village Hall
April 06	Last day for Grace Period & Early Voting at the Clerk's office.
April 09	Election Day Polling sites are open from 6:00am to 7:00pm
