GENERAL ELECTION OF NOVEMBER 2, 2010
(10 ILCS 5/2A-1(a))**

For the convenience of the voting public the Office of the Kendall County Clerk is providing the following information to Kendall County voters pertaining to the upcoming General Election. This information is not intended to be all inclusive. General Elections are held in even-numbered years.

- US Senator Special Election to fill the vacancy for the unexpired term
- Governor

- Secretary of State
- Comptroller
- Treasurer
- Representatives in Congress – All 19 Districts (Kendall County is in the 14th District)
- State Senators – For 2-Year Term
Districts 1, 4, 7, 10, 13, 16, 19, 22, 25, 28, 31, 34, 37, 40, 43, 46, 49, 52, 55, 58
(A portion of the 25th District is in Kendall County)
- Representatives in the General Assembly – All 118 Districts
- Sanitary District Commissioners / Trustees
- County Clerks
- County Treasurers
- County Sheriffs
- County Assessors
- Regional Superintendents of Schools
- County Board Members
- Judges, vacancies will be filled
- Judicial Retention

Properly filed and certified Referenda will also be placed on the appropriate ballots.

Significant Dates

August 16, 2010 Last day for local governing boards to adopt a resolution to allow a binding public question to appear on the ballot.

- August 16, 2010** **Last day to place advisory referenda on the ballot by resolution.**

- September 2, 2010** **Last day for the circuit court clerk and the local election official to certify any binding public question or advisory referenda to the proper election authority.**

- September 2, 2010** **Last day to file a notarized Declaration of Intent to be a Write-In Candidate with the County Clerk. Write-ins shall be counted only for those who have filed this Declaration.**

- October 5, 2010** **Last day for voter registration or transfer of registration**

- October 6, 2010** **First day for Grace Period registration & voting in the Offices of the Kendall County Clerk, 1st floor, Rm 103**

- October 12, 2010** **First day for Early Voting & In-Person Absentee Voting (See "Voting in Kendall County" on this site)**

- October 13, 2009** **Last day for an employee to provide written notice to their employer that they will be absent on Election Day to serve as a Judge of Election (10 ILCS 5/13-2.5, 14-4.5)**

- October 19, 2010** **Pollwatcher** & Candidate credentials available (**Organizations seeking such credentials must properly qualify for same and have registered the names and addresses of its principal officers with the Election Authority at least 40 days prior to the election. All pollwatchers must be registered to vote in Illinois)**

- October 26, 2010** **Last day Grace Period registration & voting or change of address**

- October 28, 2010** **Last day Early Voting**

- November 2, 2010** **Election Day
Polling sites open from 6:00am to 7:00pm**

- November 4, 2010** **Voter registration re-opens**

- November 16, 2010** **Complete validation & counting of absentee & Provisional/Grace ballots**

- November 23, 2010** **Canvass of election results by proper board**
