

Miscellaneous Notes:

1. All matters at 9:00 A.M. (or 8:30 A.M. for TR/CM) are set by the Clerk or the arresting agency. ALL OTHER TIMES ARE ONLY SCHEDULED BY THE COURT, with the exception of the Tuesday afternoon Juvenile Call and Detention hearings which shall be at 11:00 AM in CR 116 (J. Barnhart) as necessary.
2. All ODD-numbered divorce/family cases are assigned to Judge McAdams in CR 111 and all EVEN-numbered divorce/family cases are assigned to Judge Voiland in CR 112.
3. OP's and Emergency Motions shall be heard by the OP/Weddings Judge on their respective day, except O.P.s associated with another court file, in which case the O.P. or emergency motion shall be heard by the judge assigned to the other file (CM cases heard by the CM judge, CF cases by the CF judge, and D/F cases by the judge assigned to the D/F case), and if the assigned judge is unavailable, then the OP/Weddings Judge, or an available judge: MONDAY – J. Voiland TUESDAY – J. McAdams WEDNESDAY – J. Krentz THURSDAY – J. Barnhart FRIDAY – J. McCann.
4. Prove Ups are at 1 p.m. M-F (including jury weeks) in CR 111/112 (Judge McAdams/Voiland).
5. All jury trial settings are to be heard in CR 115 at 1:00 P.M. on the Wednesday preceding jury week.
6. TR/CM Judge may be assigned other cases (Prove Ups, and SC/LM Trials) by the Presiding Judge during the 5<sup>th</sup> week of each month.
7. Shelter care hearings to be scheduled by the Court.
8. Bond call shall be M-F at 1:00 p.m. in CR 114.
9. All TR/CM cases to be set on Officer's key date.
10. Criminal Forfeitures shall follow the underlying criminal or traffic matter, if any.
11. No matters shall be scheduled before Judges Pilmer / Krentz on the Mondays and Tuesdays or Wednesdays of jury week without leave of court.

\*\*\*\*\* Every 4th month take turns blocking Judges Barnhart, Voiland, and McAdams to do jury trials as assigned.
